



Town Council Meeting Action Items – February 21

- Town Council held a Public Hearing and approved by resolution the issuance of revenue bonds by the California Municipal Finance Authority (the "CMFA") for The Sawyer and The Parcel Phase 2.2 Apartment Affordable Housing Projects.
- Town Council provided Staff direction to work with the Town Attorney and the Mammoth Lakes Mosquito Abatement District representatives and legal counsel to develop a services agreement with the District.
- Town Council approved the Town of Mammoth Lakes and Mono County Whitmore Recreation Area Joint Operations and Maintenance Agreement, subject to final legal review and approval by Mono County.
- Town Council adopted the Resolution approving the form and authorizing execution of certain lease financing documents in connection with the offering and sale of certificates of participation relating thereto to finance the cost of construction and equipping a new town facility and the cost of acquiring certain land and improvements and authorizing and directing certain actions with respect thereto.
