CEQA Guidelines Section 15303 applies to the construction and location of limited numbers of new, small facilities or structures (e.g., the construction of one (1) single-family residence located within a residential zoning district). The State has determined that these types of projects will not have any significant environmental impacts. The project qualifies for the above-described categorical exemption, since the project consists of the construction of one (1) single-family residence located within a resort zoning district that is intended for residential use. In addition, none of the exceptions set forth in CEQA Guidelines Section 15300.2 are applicable.
