



Town Council Meeting Action Items – August 6

- The Town Council and representatives and dignitaries from the Town of Mammoth Lakes, Mono County, Mammoth Lakes Foundation (MLF), Kern Community College District, Mammoth Lakes Recreation (MLR), local arts and cultural organizations and over 50 people, attended the groundbreaking ceremony for the McCoy Arts and Cultural Center (MACC) located at 100 College Parkway.
- During the ceremony, the Mammoth Lakes Foundation presented a \$3 Million check to the Town of Mammoth Lakes as their contribution to the construction of the MACC that will unify and strengthen the arts and culture community by bringing everyone together in one custom-designed 239-seat auditorium.
- Town staff introduced new Equipment Mechanic Rigoberto Lemus Briviesca, new Permit Technician Trever Mann and new Senior Accounting Assistant Darryl Vigil.
- Town Council awarded the Task Order for McCoy Arts and Cultural Center (MACC) testing and inspections to Triad/Holmes Associates, awarded the contract for the Mammoth Yosemite Airport Multipurpose Building - Site Work phase one Project to Meyers Earthwork, Inc. in the amount of \$2,250,260.00, approved an amendment to the Mammoth Lakes Housing, Inc. professional services agreement to extend the term of the agreement to December 31, 2025, and authorized the purchase of a hangar at Mammoth Yosemite Airport for storage of Town equipment.

E-Bike Etiquette and Safety

- As e-bikes continue to grow in popularity, brushing up on e-bike etiquette is a good idea every now and then, whether you are riding one yourself or just crossing paths with someone else out for a spin.
- Specifically in Mammoth Lakes, the highlights are as follows:
 - In order to be classified as an e-bike, the bike must have pedals. Pedal-less electric bikes are not considered e-bikes and are classified as electric motorcycles.
 - All classes (1, 2, & 3) of e-bikes are allowed on the paved multi-use pathways (MUPs) in the Town of Mammoth Lakes.
 - E-bikes are permitted on all streets, roads, off highway vehicle (OHV) routes, and soft surface trails within the Mammoth Mountain Bike Park.
 - E-bikes are NOT permitted on soft-surface, non-motorized trails outside of the Mammoth Mountain Bike Park.
 - All bicycle riders are required to wear a helmet and follow the same laws as cars when riding on streets and roads.
 - Unless modified to be street legal in conjunction with a motorcycle license, pedal-less electric bikes (motorcycles) are only permitted on OHV routes and are NOT permitted on any town roads, sidewalks, or MUPs.
 - Electric motorcycles are not permitted on the MUPs.
 - The speed limit on the multi-use pathways (MUPs) is 15 mph and reckless operation is prohibited.
