## ORDINANCE NO. 2010-12

AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF MAMMOTH LAKES, STATE OF CALIFORNIA, ADDING SUBSECTION D TO SECTION 12.20.500 OF THE TOWN OF MAMMOTH LAKES MUNICIPAL CODE, SKATEBOARD AND IN-LINE SKATING FACILITIES OWNED OR OPERATED BY THE TOWN

THE TOWN COUNCIL OF THE TOWN OF MAMMOTH LAKES, STATE OF CALIFORNIA DOES ORDAIN AS FOLLOWS:

Section 1: AMEND CHAPTER 12.20.500 OF THE TOWN OF MAMMOTH LAKES MUNICIPAL CODE AS FOLLOWS:

a. Amend Chapter 12.20.500 as stated in Attachment A.

Section 2: EFFECTIVE DATE OF ORDINANCE

This ordinance shall become effective and enforceable thirty (30) days from and after the date of its adoption.

Section 3: POSTING

The Town Clerk shall, within fifteen (15) days after the passage of this Ordinance, cause it to be posted at the duly designated posting places established by resolution of the Town Council, published once in a newspaper of general circulation, and entered in the Book of Ordinances of the Town.

Section 4: SEVERABILITY

If any provision of this Ordinance of the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications, and to this end the provisions of this Ordinance are declared to be severable.

The foregoing Ordinance was introduced on the 22nd day of September, 2010 and PASSED, APPROVED AND ADOPTED on the 6<sup>th</sup> day of October, 2010.

	With respect to any skateboard facility or inline park owned or operated by the town, any person riding a skateboard, inline skates, or similar device shall wear a helmet, elbow pads and knee pads at all times.

	The town shall post signs at all facilities affording reasonable notice that any person riding a skateboard or inline skating in a facility designated for one or the other of these purposes must wear a helmet, elbow pads and knee pads, and that any person failing to do so shall be guilty of an infraction and subject to citation.

	Any person who fails or refuses to comply with the provisions of this section and who is injured while using the park or facility shall be deemed negligent per se.	
D.		
	No person shall use the skating surface of the Volcom Brothers Skate Park other than for proper use of a skateboard or in-line skates. Use of a bicycle on the skating surface of the Volcom Brothers Skate Park is strictly prohibited and any person failing to comply with this requirement shall be guilty of an infraction and subject to citation.
