SUBJECT: Notice of Intent to Adopt/Notice of Availability for the Mono County Search and Rescue Building (UPA 10-005) Initial

Study/Mitigated Negative Declaration

This serves as the Town of Mammoth Lakes (Town) Notice of Intent to adopt an Initial Study/ Mitigated Negative Declaration for UPA 10-005, a new Search and Rescue facility, prepared in accordance with the California Environmental Quality Act (CEQA), State CEQA Guidelines and local implementation procedures.

PROJECT TITLE: Use Permit Application (UPA) 10-005 - Search and Rescue ("Project")

PROJECT LOCATION: The Project is located on a portion of the property owned by the Mammoth Community Water District at 1315 Meridian Boulevard, Mammoth Lakes in Mono County, California.

PROJECT DESCRIPTION: The Project is for a new, permanent facility for the Mono County Sherriff's Search and Rescue. The facility would be located on an approximately 18,000 square foot site in a building that could accommodate up to seven vehicles and a small office and meeting area.

NOTICE IS HEREBY GIVEN THAT the Town of Mammoth Lakes proposes to adopt a Mitigated Negative Declaration for the above-cited Project. The Mitigated Negative Declaration is based on the finding that, by implementing the identified mitigation measures, the Project's potential significant adverse impacts will be reduced to a less than significant level. The reasons to support such a finding are documented by an Initial Study prepared by the Town of Mammoth Lakes.
