RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MAMMOTH LAKES, STATE OF CALIFORNIA, RESCINDING THE COMMUNITY BENEFITS AND INCENTIVE ZONING (CBIZ) POLICY (COUNCIL RESOLUTION 09-55)

WHEREAS, on August 5, 2009 the Town Council adopted the Community Benefits and Incentive Zoning (CBIZ) Policy as Resolution 09-55; and

WHEREAS, the CBIZ Policy functions as a tool to help the Town consider and evaluate requests for legislative and discretionary amendments and is intended to serve as a "bridge" framework to be applied until Community Planning documents, including District Plans, the Trail System Master Plan, and the Parks and Recreation Master Plan, were completed; and

WHEREAS, a Townwide District Planning document was accepted by Town Council on August 3, 2011; and

WHEREAS, the Trail System Master Plan was adopted by Town Council on October 11, 2011; and

WHEREAS, the Parks and Recreation Master Plan was adopted by Town Council on February 1, 2012; and

WHEREAS, the Council desires to reduce uncertainty for project applicants and developers regarding the permit process; and

WHEREAS, each development project and permit is required to comply with the appropriate findings identified in the Town's Municipal Code; and

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Mammoth Lakes, California, as follows:

- 1. That the Town Council finds the above recitations are true and correct.
- 2. The Town Council incorporates by reference all exhibits and attachments cited in this Resolution.

- 3. Pursuant to the requirements of the California Environmental Quality Act (CEQA), the Town Council makes the following finding: rescinding the CBIZ Policy would be exempt from CEQA pursuant to the General Rule, CEQA Guidelines 15061(b)(3), because there is no possibility that this action would have a significant effect on the environment.
- 4. The Town Council takes the following action: the CBIZ Policy shall be rescinded immediately.
- 5. The documents and other materials that constitute the record of proceedings upon which the Town Council's decision is based are located in the Town Offices of the Town of Mammoth Lakes, at 437 Old Mammoth Road, Suite R, Mammoth Lakes, California 93546 and Jamie Gray, Town Clerk, is hereby designated as the custodian of these records.
