A tax return must be filed every month, even if no revenue is collected, or no tax is due.

If hand-delivered to the Town offices, the return must be received by 5 PM on the due date.

If mailed, the envelope must be postmarked by the due date. USPS, UPS, or FedEx postmarks will be accepted but self-metered postmarks will not be accepted. Postmarks are imprints on letters, flats, and parcels that show the name of the postal office that accepted custody of the mail. The postmark is generally applied, either by machine or by hand, with cancellation bars to indicate that the postage cannot be reused. Taxpayers who send their payments by mail are cautioned that the USPS may not postmark mail on the same day deposited by a taxpayer. The Town recommends that you bring your envelope to the counter to request a same day postmark.

If filing online through XpressBillPay.com, you will have until 11:59 PM PDT on the due date to file and remit full payment.
